Talbott holds a J.D. from Hofstra University School of Law and a B.A. in political science with a minor in socio-legal studies from The State University of New York at Stony Brook. She also holds certifications in executive leadership from American University, diversity equity and inclusion from Cornell University, and corporate board readiness from Santa Clara University. Talbott is also a <u>children's book author</u>; "Sammie and Sally Move Around Town," the first book in the Sammie and Sally series about safe transportation, is now <u>available on Amazon</u>.
